ORDINANCE NO. __1131

AN ORDINANCE AMENDING ORDINANCE NUMBER 645 AND SECTION 20.16.030 OF THE MUNICIPAL CODE OF THE CITY OF FAIRFIELD, IOWA.

BE IT ORDAINED by the City Council of the City of Fairfield, Iowa:

SECTION I. The Zoning and District Map dated March 26, 1996 and referred to in Section 20.16.030 of the Municipal Code of the City of Fairfield, Iowa, is hereby changed and amended in the following respects:

(a) The following described territory within the corporate limits of the City of Fairfield, Iowa, is hereby changed from R-1 Single Family Residential District to M-2 General Manufacturing District.

The South half of the Northeast fractional Quarter of Section One (1) in Township Seventy-one (71) North of Range Ten (10) West, containing 81.43 ½ acres, more or less, in Jefferson County, Iowa, EXCEPT A parcel of land located in the SW ¼ NE Fractional ¼, and the SE ¼ NE Fractional ¼, all in Section 1, Township 71 North, Range 10 West of the 5th P.M., Jefferson County, Iowa, as shown on Acquisition Plat conveyed to the State of Iowa, recorded in Image 2004-1853, and more particularly described as follows: Beginning at the NE Corner of the SE ¼ NE Fractional ¼; thence S 84°10′40″ W, 1641.02 feet; thence N 85°40′44″ W, 267.04 feet; thence S 86°23′02″ W,771.15 feet, to a point on the west line of the SW ¼ NE Fractional ¼; thence N 0°38′25″ W, 396.37 feet, on said west line; thence N 87°16′22″ E, 2673.50 feet, on the north line of the SW ¼ NE Fractional ¼ and the SE ¼ NE Fractional ¼ of said Section 1, to the Point of Beginning; containing 23.34 acres. Note: The east line of the SE ¼ NE Fractional ¼ of said Section 1 is assumed to bear S 0°25′11″ E for the purpose of this description. Subject to all easements of record.

SECTION II. This Ordinance shall be in full force and effect after adoption and publication as required by law.
